As the commanding officer of the NYPD legal affairs unit, Chernyavsky's legal opinions have helped shape NYSACOP's direction on legal matters.

On September 12th, 2022, Commissioner Keechant Sewell announced the appointment of Oleg Chernyavsky to the position of Chief of Staff to the Police Commissioner. I am extremely pleased to add Mr. Chernyavsky to my executive team," said NYPD Commissioner Keechant L. Sewell. "His decades of service with the New York City Police Department have established him as one of the premier law-enforcement professionals in our city. I look forward to working closely with him and the rest of our team as we continue to fight for every New Yorker, in every New York City neighborhood."


Oleg Chernyavsky joined the New York City Police Department as an attorney in October 2002, assigned to the department's Legal Bureau. He rose through the ranks, and was promoted to Assistant Deputy Commissioner, Legal Matters in June 2019. In this role, while simultaneously overseeing all the Legal Bureau's attorneys and support staff, he served as an advisor to the police commissioner and other NYPD executives on a variety of legal topics and policies as they relate to policing. Mr. Chernyavsky also served as the NYPD's liaison with various city, state, and federal elected officials, as well as police executives and prosecutors throughout New York State. While assigned to the Legal Bureau's Civil Enforcement Unit, Mr. Chernyavsky spearheaded the reconstruction of the department's vehicle forfeiture program and prosecuted nuisance abatement actions. During his time at the Legal Bureau's Criminal Section, he advised and trained members of the department on a variety of topics, represented the NYPD at community council meetings, and advised the Detective Bureau on numerous investigations, including several high-profile and newsworthy crimes and investigations. His mission has also involved analyzing complex legislative matters at all levels of government and working closely with agency executives on confidential and sensitive matters. Mr. Chernyavsky has conferred frequently with the Mayor's Offices of Federal, State, and City Legislative Affairs as well as with elected officials and other city agencies. Additionally, he serves as the NYPD liaison to the New York State Association of Chiefs of Police and served as the police commissioner's voting representative on the Governor's Criminal Justice Task Force. Mr. Chernyavsky earned a Bachelor of Science degree from St. John's University, a master's degree in international relations from Syracuse University's Maxwell School, and a Juris Doctor degree from Syracuse University


The Southampton Town Police issued a statement;



Extreme Risk Protection Orders - An Overview for Law Enforcement Webinar Recording

The New York State Division of Criminal Justice Services (DCJS) in conjunction with Everytown for Gun Safety presented an informational webinar for law enforcement entitled "Extreme Risk Protection Orders-Overview for Law Enforcement". This presentation was conducted as part of the DCJS Law Enforcement webinar series and is about an hour in duration.

Established in NYS Civil Practice Law and Rules, Extreme Risk Protection Orders (ERPO) are a court-issued order of protection designed to protect the community by prohibiting a person who show signs of being a threat to themselves or others from purchasing, possessing, or attempting to purchase or possess a firearm. This webinar will provide an overview of when police officers are now required to file ERPO petitions. In addition, the webinar will provide a best practices overview of law enforcement relevant components of NYS Civil Practice Law and Rules Article 63-A to include:

- Identifying extreme risk behavior
- Process for filing and executing the ERPO
- Best practices for serving the ERPO
- Process for extending or terminating the ERPO



Middletown, NY Man Arrested for Felony DWI After Striking Troop Car on Palisades Parkway

On September 25, 2022, at approximately 5:21 a.m., State Troopers were stopped behind a vehicle on the Palisades Parkway. Troopers observed a 2020 Nissan Rogue stopped on the Parkway northbound in the town of Stony Point with its hazard lights on. Troopers approached the vehicle and spoke with the operator. While speaking to the operator troopers determined that she was impaired by alcohol. She was subsequently arrested for DWI and transported to the State Police barracks in Haverstraw by another trooper. The troopers were sitting behind the Nissan with emergency lights on while waiting for the vehicle to be towed from the parkway. Troopers were struck from behind by a 2001 Mazda, operated by **Donald C. Bolling**, age 44 from Middletown, NY. Troopers determined that Bolling was impaired by alcohol and traveling with a three -year-old. He was subsequently arrested and charged with Aggravated DWI- Leandra's Law and Endangering the Welfare of a Child. He was issued 13 tickets. Bolling had a BAC of .12%. He was arraigned in the Town of Stony Point Court in front of Judge Franks and remanded to Rockland County Jail without bail and scheduled to reappear on September 29, 2022, at 10:30 a.m.

Both troopers received minor injuries and were treated and released from Nyack Hospital. Bolling and the child were not injured.
